RULES AND REGULATIONS FOR AVAILING SCHOOL TRANSPORT

1. Once the transport facility availed can’t be discontinued before end of the session.
2. The student who wants to discontinue the transport facility in the mid of the session has to pay up to end of the session.
3. In general, the enrolled students are required to pay transport fee for the entire session, irrespective of holiday and vacations.
4. The school reserves the right to increase transport fees on price hike of vehicles consumables, fuels etc.
5. The school reserves the right to fix up the boarding points of bus routes.
6. Change of boarding point can be allowed only with prior permission of the School Authority by paying **Rs. 500** (In case new fare remains the same),and **Rs. 700** (In case new fare gets change).
7. Only the enrolled students with valid bus pass are permitted to travel the school bus.
8. The students are expected to maintain utmost discipline inside the bus while travelling.
9. The students must reach their boarding point 10 minutes before the notified time.
10. The students must behave properly with the bus staff and follow the instructions given time to time.
11. The senior students should offer seats to their juniors during travel.
12. While boarding / getting down, the students must not run beside the bus.
13. The transport fee has to be deposited between 15th to 30th of the same month.
14. If Transport card is lost, Rs. 50 will be charge to get the new card issued.
